- A. Office of Science Nuclear Physics:** The purpose of this contract modification is to deobligate funds under the American Recovery and Reinvestment Act of 2009 for the Office of Science Nuclear Physics project entitled "Enhanced Utilization of Isotope Facilities".

The project code that should be used to track this Recovery Act funding in the Project section of the Accounting Flex Field in STARS/IDW is 2005230.

- B.** Accordingly, pursuant to Section I, Contract Clause, "Obligations of Funds" and Section B, Contract Clause, B-2, "Obligated Funds", funds in the amount of **\$230.40** are hereby deobligated related to Recovery Act activities. The total amount of funds obligated under this contract since the inception is decreased from **\$14,895,151,894.34 to \$14,895,151,663.94**.
- C.** The specific work funded by this modification is described in the work authorization titled, "Enhanced Utilization of Isotope Facilities" (Project Code #2005230).
- D.** The work described in this modification shall be performed using funds obligated under this contract, which have been appropriated under the American Recovery and Reinvestment Act of 2009, Pub. L. 111-5, and as such, is subject to the special statutory conditions and the additional contractual terms and conditions that were incorporated into the contract at Modification No. A508. The funds obligated hereunder shall only be used to accomplish the work as set forth in paragraph C. above and may not be used for any other purpose without the prior written consent of the Contracting Officer.
