Purpose of Modification:

The purpose of this contract modification is to incorporate the DOE guidance regarding Executive Order 13423 and the Transformational Energy Action Management (TEAM) initiative, set forth in DOE Acquisition Letter 2007-12.

Description of Modification:

The following change is hereby incorporated into the contract:

1. Section C, "Description/Specifications/Work Statement", Clause C-4.2.8 "Other Related Work and Operation of the Laboratory" currently includes two unnumbered paragraphs. Clause C-4.2.8 is hereby changed to include the following new language as the third paragraph of the clause:

"The contractor shall assist DOE through direct participation and other support in achieving DOE's energy efficiency goals and objective in electricity, water, and thermal consumption, conservation, and savings, including goals and objectives contained in Executive Order 13423, Strengthening Federal Environmental, Energy, and Transportation Management. The Contractor shall maintain and update, as appropriate, its Site Plan (as required elsewhere in the contract) to include detailed plans and milestones for achieving site-specific energy efficiency goals and objectives. With respect to this paragraph, the Plan shall consider all potential sources of funds, in the following order: 1) the maximum use of private sector, third party financing applied on a life-cycle cost effective basis, particularly from Energy Savings Performance contracts and Utility Energy Services Contracts awarded by DOE; and 2) only after third-party financing options are evaluated, in the event that energy efficiency and water conservation improvements cannot be effectively incorporated into a private sector financing arrangement that is in the best interests of the Government, then DOE funding and funding from overhead accounts can be utilized." 2. There are no other changes to the terms and conditions of the contract. The contractor hereby releases the Government from any and all liability under this contract for equitable adjustments attributable to this contract modification.
